Legislative update...

The Legislative Coalition of Virginia Nurses tracks bills related to nursing interests in Virginia. I represent Virginia AWHONN at the meetings as well as serve as the President of LCVN, and was present at the January 9 meeting.

If you want to follow the bills, you can like LCVN on Facebook or ask me to follow bills on specific topics. You can also find information about the bills in Virginia from this website: <http://lis.virginia.gov/> If you want to know who your representative is or contact that person about a bill, use this website:

Bills of interest include:

HB489/SB158--requires sexual assault evidence to be processed

HJ29/HR19--Life begins at conception

SB20--places member of ACOG on medical home advisory council, but not nurses

SB81--curriculum for law enforcement of sexual assaults on campus

SB183--removes prohibition against insurance coverage of abortion

SB248--allows a minor who has been sexually assaulted to be deemed as an adult for evidence recovery

SB264--NPs with 2,000 hours of supervised experience can practice without supervision in medically underserved areas and FQHC

SB265--enhanced compact so nurses can practice in several states--VBON would like us to contact Sen. Dance and offer support--those of us currently with multi-state compact will be grandfathered into new enhanced compact

Also, the Governor has put money in the budget for access to birth control.

The next meeting of LCVN will be Feb. 16 at 4:00 in Richmond. All are welcome to attend. If there is a bill that you want me to gain more information about, please contact me at Nina.Beaman@aspen.edu and I will have LCVN follow it for you.
